Without you, we would not be who we are today – a fantastic waterfront association that offers more to our members and especially our children than most associations and campgrounds with which I am familiar.

There are simply too many names to list, but I do need to recognize Don Smith as the keeper of our calendar and coordinator of our social events. Without Don's efforts, we would not be as organized nor would our events run as smoothly as they do. Please thank Don and the other active Association members who organize the events, especially the weekly Craft Night and Children's Bingo. Don't forget our newsletter editor Mike Trocchi, who remains in the background but without whom you

would not be reading this.

For details on Board activities, please visit our website and review the materials posted, including Board meeting minutes. The Board has been active addressing items from both Town Hall meetings as well as individual member concerns. These include:

- Developing guidelines and creating a business management system including both written and email correspondence to remain in compliance with the Freedom of Information Act.
- Creation of two subcommittees within the Board to identify specific homeowner issues and concerns and to propose solutions regarding Pilgrim Way and Glimmer Glen.
- Identifying and managing 21 Association properties including rights of way. This includes reclaiming rights of way, expanding access

to the water for association members, management of the beach areas, expanding seasonal boat storage areas and routine maintenance projects.

- Managing goose poop issues – a concern for all and an issue difficult to address as anyone who has been here for more than a few years can attest. Some years are worse than others and there are no simple solutions. This is an annual concern and receives the most complaints. Many homeowners have researched this issue and shared with the Board. This will continue to be an issue for years to come and we will do our best to realistically address it.
- Managing insurance coverage: Bouvier Insurance continues to be our agent and coverage has been secured for another year.
- Refining and updating beach

Property taxes due this week; deadline to avoid interest is Aug. 3

Don't be late! The final date to pay your Lake Hayward property taxes is Aug. 3 in order to avoid an interest charge of 1.5% per month on payments made after that date. If you are mailing your tax payment, it needs to be post-marked on or before Aug. 3. If the postmark is not clear, then the date received is the determining date. Mail your payments now to avoid confusion and interest payments later.

If you have not received your 2015-16 property tax bill or you misplaced it somewhere, please call or e-mail Ed Bader (860-295-8769 or edbader@aol.com) for a duplicate copy. He can fax, e-mail or mail a copy to you so you can mail it in on time. Or he can give you the amount of the bill and you can write a check immediately and put the check in the mail immediately with your Lake Hayward address

on the check so the payment will reach us by Aug. 3.

For the 16 property owners who still owe 2014-15 property taxes, payment on those delinquent accounts is due by Aug. 3, too. Any of these accounts not paid by Aug. 3 will be turned over to our attorneys for collection and that process is expensive because the delinquent property owner pays all the costs of collection.

Public Safety Update: Prevent drownings by watching your children closely

Did you know that, on average, 27 people die as a result of drowning in Connecticut each year? Here are some myths associated with drownings:

- Myth: Drowning victims call for help.

Fact: Drowning is suffocation in water, it's a silent death.

- Myth: Drowning victims are alone when they go under.

Fact: Drownings occur in the middle of crowds. Drownings are often mistaken for play, as victims try to push themselves out of the water.

- Myth: Drownings don't occur quickly.

Fact: Drownings can occur in as little as 20 seconds.

- Myth: Victims are usually swimmers who went too far.

Fact: Drowning victims are usually poor swimmers or non-swimmers who never intended to enter the water.

- Myth: Children are safe if they know how to

swim and wear a personal floatation device.

Fact: Children can easily panic and forget what they've learned. No one is ever "drown-proof," not you nor your kids.

- Myth: If my boat sinks I can always swim to shore.

Fact: Many people, including strong swimmers, can be overcome by hypothermia in cold water and drown.

Cold water is dangerous, and the shoreline may be farther than it looks.

To prevent drownings in our lake, you should:

- Always supervise your children in and around water. Don't leave them alone, even for an instant!
- Always wear a life jacket! Connecticut law requires anyone under 12 must wear a life jacket while on a boat.
- Make sure the whole family learns to swim.
- Never swim alone.

- Learn CPR.
- Look before you leap.
- Drinking and swimming is just as dangerous as drinking and driving.

Keep these tips in mind when fitting yourself or your child in a life jacket:

- Life jackets are not like clothes - you DON'T grow into them.
- Life jackets should be Coast Guard-approved and the correct size for your weight.
- Life jackets should fit snugly. The shoulders of the life jacket should not come up above the nose or ears when pulled up or it will not stay on in the water.
- If your child's weight exceeds the children's sizes, you must purchase an adult-sized life jacket for them.
- Life jackets are important, but they are never a substitute for adult supervision.

- Promoting public safety through hiring private duty police patrols in our neighborhoods, posting signage and notes in our newsletters.
- Reviewing and updating a policy on the "One Foot Reserve" boundary line surrounding the Association, including current legal interpretations and validity of this once commonly accepted practice.
- Working with standing committees to assure

they are properly funded and events are organized.

- Working with the Lake Quality Improvement Committee to improve our quality of life and protecting our most valuable asset, Lake Hayward. This includes weekly testing of the lake water.
- Conducting normal business affairs required of any organization.

Monday garbage pickup continues until Sept. 8

All-Waste Control will collect trash and recyclables twice a week (Monday and Friday) through Sept. 8. The Town of East Haddam has implemented "single stream recycling" so it is no longer necessary to separate the various recyclables into separate containers and/or put them out on separate days. All recyclables can be combined and placed into a single container and put out with your regular trash. We must recycle:

1. Glass and metal food and beverage containers (rinsed); lids go in trash

(No broken glass, mugs, windowpanes, ceramics, light bulbs, mirrors, dishes or tempered glass)

2. Plastic containers Nos. 1 through 7 (rinsed); lids go in trash
3. Newspaper, magazines, cereal/pasta boxes, milk and juice cartons, junk mail (No phone books, wax- or plastic-coated cardboard, soiled newspaper or magazines, books, plastic (Tyvek) envelopes)

4. Cardboard (broken down) (No wax coated boxes, soiled boxes, pizza boxes)

Please place your trash in a covered container if it will be outside at night.

All persons liable to pay real estate taxes to the Property Owners' Association of Lake Hayward as levied on the October 1, 2014 Grand List are hereby notified that the taxes are due and payable on July 1, 2015 at the mill rate of 3.50. The taxes will become delinquent on August 3, 2015 if not paid by this date. Delinquent tax bills shall be subject to interest of 1.5 percent per month reverting to the due date, July 1, 2015. The minimum interest charge is \$2. All persons in the Tax District who do not receive a tax bill should call the Tax Collector at 860-295-8769 to obtain their bill before the end of the grace period, August 3, 2015. Failure to receive a property tax bill does not invalidate the payment of the tax or related delinquent interest charge if not paid by August 3, 2015. Tax payments shall be made by mail to Tax Collector, Property Owners' Association of Lake Hayward, Post Office Box 230, Colchester, CT 06415.

Voter registration update: The how, why and origins of lake voting

During the dredging project discussion at the August 2014 POALH Annual Meeting, the subject of who was eligible to vote at POALH meetings came up. Then-president Gail Miers stated that those who were registered at the sign-in table and wearing nametags could vote. This question prompted the Board to look further into voting requirements, and we found that our Charter addresses the issue.

Section 1 of our Charter, Voting Rights, states “Any natural person who is an elector of the Town of East Haddam and resides within said limits of the Association or who has attained the age of eighteen years and owns any legal lot within said limits which has an assessed value equal to or in excess of one thousand dollars and has registered with the secretary-clerk of the Association shall, while he or she continues to be such elector and resident or an owner of such lot, be a member of the Property Owners’ Association of Lake Hayward, shall be entitled to vote at any meeting or referendum of said association and shall be eligible to hold any office in said association. No member shall be entitled to more than one vote.”

The 2015 POALH spring packet contained a Voting Registration Form and a message from Secretary-Clerk Bonnie Sudell, advising that, per our Charter, members of the POALH should be registered with the Secretary-Clerk to be able to vote at meetings and referendums. This form generated considerable discussion at our June meeting, including a motion to form a committee to review the Charter regarding the “registered voter” definition and voting rights of POALH members, not make any changes prior to the August meeting and to bring suggestions to the August meeting.

Gail Miers and Bonnie Sudell were asked to spearhead the committee and seek legal opinion from our attorney. Diane Camacho and Jo-Anne Gallant came forward to help interpret our attorney’s response. Here is the result of this committee’s work:

Why do we need to register to vote?

To simply say “because it is in the Charter” won’t combat the attitude that we have always voted without registering and there is no need to change the “past practice.” However, as soon as the Board had knowledge of the voter registration requirements and informed the members, any subsequent votes that we take without following the proper procedures can be called into question by any member. As a political subdivi-

sion of the State of Connecticut, we are subject to State laws that govern taxing districts and like it or not, voter registration is included. As long as the language is in the Charter, the association members need to abide by it for votes taken at meetings to be legal and binding.

Are we the only lake association in Connecticut to require voter registration?

Not all of the lakes in the state have lake associations. Some lakes, such as the nearby Lake Andover require memberships, and one need not be a lake resident to join, but membership was required to be able to vote. Two lakes, Cedar Lake (Bristol/Wolcott Conn.) and Lake Quassapaug (Middlebury, Conn.) did have their bylaws online. The bylaws indicated that to vote, one needed to live within the boundaries outlined and purchase a membership (\$500 and \$100 respectively) which provided one member of the household one vote at their annual meeting. Several of the lakes with associations had websites that were not as comprehensive as ours and basically listed rules, regulations and events. A visitor to the site had no access to the association’s charter or bylaws, so determining who could vote wasn’t possible. One even had a member login so non-members could not access it.

Who is eligible to register to vote?

In order to be eligible to register with the secretary-clerk to vote, you must meet one of two conditions. First, you must be a natural person who is an elector of the Town of East Haddam and live within the lake boundaries. Second, you may be eighteen or older and own a lot within the lake boundaries with a value in excess of one thousand dollars.

What does our Charter mean by “Any natural person?”

The Charter uses the term “Any natural person” which immediately eliminates companies such as the Connecticut Water Company, which owns land, from having a vote. Likewise, a corporation or LLC (limited liability corporation) which owns a cottage cannot vote because they are not a natural person. If an individual, tenant or member, from the corporation is a resident of the cottage and an elector of East Haddam, they satisfy the Charter and can register to vote.

What about trusts and estates?

If a property is listed as a trust with no co-owner listed, there is no natural person and therefore no vote. So if the language of the trust

reads ‘the living trust of John Doe’, John cannot vote unless John resides at the property and is an elector of East Haddam. However, listed co-owners may register with the secretary-clerk and vote even if they are not electors of the Town because they own property valued at least \$1,000. So if the trust reads John and Jane Doe and the living trust of John Doe, both are eligible to register and vote. If just John’s name is on the trust, his wife must live at the lake and be an elector of the Town to be eligible to register to vote.

If the property is held in a Life Estate Deed, the situation is similar to that of a trust. All of the owner(s) of the life estate may register to vote if they are specifically named on the life estate deed. Otherwise, they must reside at the lake and be electors of the Town.

What about deeded properties?

Anyone listed on the deed may register to vote with the secretary-clerk. If a spouse is not on the deed, or the property has other owners not listed, they cannot vote unless they are residents and are registered as an elector of the Town of East Haddam. Children of the owner may register to vote with the secretary-clerk if they are residents and are registered as an elector of the Town.

What if you own multiple properties?

If you own multiple properties and are listed on multiple deeds, you only have one vote. The number of properties doesn’t matter.

What about renters?

Renters may register with the secretary-clerk to vote if and only if they live within the lake boundaries and are registered as electors with the Town of East Haddam.

What can we do if we are dissatisfied with the voter registration process?

As the language regarding voter registration is in the Charter, and the Charter was accepted by the Connecticut state legislature, there is little we can do. Changing the Charter literally takes an ‘Act of Congress’ and the state legislators would rather not deal with what they consider a minor issue.

Even if we voted to change the Charter, it could take several years before changes could be made. In the meantime, it is in our best interests to abide by the voter registration process so that votes taken at our annual meeting are legal and binding.

Beach Rules



1. Parents or chaperones are responsible for their child’s safety and their child’s actions at all times.
2. Children cannot be left at the beach unattended.
3. Infants must be in leak-proof diapers at all times.
4. No fishing from the beach and within 25 feet of swim area.
5. Dogs are never allowed on the beach.
6. Vehicles are not allowed on any beach at any time.
7. No glass on any beach or in the pavilion.
8. All trash and cigarette butts must be removed from the beach and beach area and disposed of properly.
9. Use of the beach and beach area is limited to Association members and their guests.
10. Cars parking in a beach parking area must display a current POALH parking permit.
11. Beaches and Association properties are closed from Midnight to 6 a.m. Police take notice.
